• Certificate Of Conformity (CoC)

Pressure Equipment Regulations (PER) requires that a CoC be issued by a registered gas installer on every installation.

A CoC is valid for as long as there is no modification, alteration (to the installation) or change of ownership (of the property).

Visit the SAQCC Gas (<u>https://saqccgas.co.za/</u>) to get a registered installer.

Permitted cylinders

Pressure Equipment Regulations (PER) requires that all importers and manufactures of cylinders obtain a permit before the cylinder is place in the market. LPGSA has been mandated the Department of Employment and Labour to provide such a permit.

Permitted appliances

In terms of the Pressure Equipment Regulations (PER), it is mandatory for appliances, hoses and regulators falling within the scope of the relevant South African national standards to be tested for compliance and for the manufacturers/ importers of such products to obtain a Verification Permit from the LPGSA who has been mandated by the Department of Employment and Labour as the Verification Authority for LPGas appliances.

Always make sure:



- ✓ You always read the manufacturer's manual.
- ✓ Keep your cylinder secured and appliance(s) protected.
- ✓ Your family & children know how to use LPGas safely.
- √ your gas appliance and cylinder are checked/maintained by your gas dealer.

Avoid taking your cylinder to an unauthorized dealer as they maybe underfilled, overfilled and lack of maintenance.

Simple checks:



1 Check all washers on the appliance & O-ring on the regulator and replace the if needed.



2 Check clamps and hose connections



3 Check the hose for cracks/wear and always keep the hose away from the heat

If you smell gas:

Immediately turn off the cylinder by turning



- Do not unscrew or remove the regulator or appliance if gas has not been properly turned off at the cylinder.
- Ensure the room is well ventilated.
- Open doors and windows to let in fresh air
- If possible, take the cylinder & appliance outside
- If there are flames, try to turn off the cylinder. Use a damp towel to protect your hands



 Make sure there is no gas in the room before you try to relight the appliance

handwheel

or key clockwise

- If you are sure that you a leak has been found and stopped the leak, take the cylinder to the dealer
- Do not place a leaking cylinder in your vehicle
- Never look for a leak with a naked flame.



- Use soapy water to perfom a leak test
- Never attempt to reuse a cylinder that has been in a



Using & caring for your cylinder:



Never leave the gas cylinder on a stove or near heat.

By law, no more than 19kg of LPGas can be kept inside a house and no more than 9kg of LPGas can be kept inside per flat.

A spare cylinder can be kept outside the house (for max volume of LPGas allowed on a site check with local authority)



Place your cylinder on a level surface

An approved appliace will have a safe appliance mark



Pressure Equipment Regulation (OSHAct):

PER also lays out responsibilities for the end user.

Pertinent points as per Regulation 6 include:

- Appliance is permitted.
- ✓ Gas practitioner is authorised.
- ✓ In possession of a valid CoC .
- ✓ Maintenance of the pressure equipment
